Reservations and Cancellations: Reservations accepted on a first-come basis and must be accompanied by a \$600 per person deposit. All cancellations must be in writing and are subject to a non-refundable \$200 per person fee. Cancellations received 69-45 days prior to departure are subject to a fee of 75% of program cost per person; ; Cancellations received 44-0 days before departure are subject to a 100% cancellation fee. No refund given for unused services.

Program Cancellation: Great Time tours, Ltd., its management, staff, officers, and affiliate agents hereinafter referred to as GTT reserves the right to cancel any program for lack of sufficient participation.

Program Price: Program price as stated includes features as outlined and is valid up to 45 days prior to departure date; thereafter, program participation is subject to availability and possible price increase.
